If an Owner cannot attend the Annual Homeowners Meeting and would like to appoint a Proxy to cast a ballot on their behalf, Owners may request their proxy document from the RHOA Property Manager at [RHOA@RIDGESHOA.COM](mailto:RHOA@RIDGESHOA.COM) or at RHOA c/o P J Morgan, 7801 Wakeley Plz, Omaha, NE 68114 from June 1 through June 12. The Owner, with their appointed Proxy's name legibly printed, must sign the proxy document. The appointed Proxy may be a spouse (if both are not Owners), or another Owner, as no guests are permitted at this meeting. The appointed Proxy may then obtain the Owner's ballot at the Annual Homeowners Meeting.

Please be aware that once an Owner has appointed a Proxy, their Proxy may vote however they wish. If an Owner requests a proxy document, then prefers to attend the meeting and cast a ballot in person, they must bring the proxy document to the meeting with the appointed Proxy's name crossed out.

The proxy document is valid only for the 2016-2018 RHOA Board of Directions Election on June 15, 2016.
